According to Article 9(4) of the ICCBA Constitution, to the extent practicable, a minimum of one seat on the Executive Council is respectively reserved to Counsel or Associate Members native to the following areas:

- Asia Pacific States
- Central and European States
- Latin American and Caribbean States
- North American States
- North African States
- Sub-Saharan African States; and
- Western European States

There were candidates from all these areas, except for Latin American and Caribbean States, and North African States.

Pursuant to Article 9(4), Mr. Mayombo Kassongo is allocated the reserved seat as the representative of the Sub-Saharan African States, regardless of the number of votes received.
